Event Recap: 2024 Joint Technical Symposium (JTS)

The nearly sold out 2024 Joint Technical Symposium was held on October 10th and has continued its record of being a highly valuable and informative event for attendees. Regulatory Update: Cal/OSHA Lead Standard

The new Lead standard is set to go into effect on January 1st, 2025. Significant changes were made including lowering the Action Level to 2 μg/m³ and the Permissible Exposure Level to 10 μg/m³. Changes were also made to the exposure assessments, blood lead testing, and temporary medical removal. Under General Industry, Separate Engineering Control Airborne Limits (SECALs) were set for Lead Acid Battery manufacturing and recycling facilities.
