The Cal/OSHA Rule Making Process

The Cal/OSHA standards board recently approved an update to the Respirable Crystalline Silica standard, expected to go into effect later this Spring. You may find yourself wondering – what is the process to create these standards and how can employees and employers be heard during this process?

New and revised standards go through a long process to become the regulations applied to workplaces. First, the Cal/OSHA staff will prepare a rulemaking package that includes the proposed regulation, initial statement of reason, economic impact, and notice of proposed rulemaking. This package is reviewed by the Standards Board staff and then submitted to the Labor Agency and then the Office of Administrative Law.

The public has opportunities to be involved in the rule making process through comment periods and public hearings. The Standards Board will provide a 45-day notice before the standard is reviewed in a public hearing, where the Board will hear public comment. If necessary, Cal/OSHA will revise the proposed standard and then a 15-day comment period will take place. An additional 15-day comment period may take place depending on the circumstances and feedback receive during comments periods and public hearings.

After the final standard is approved by the Standards Board, it is submitted to the Office of Administrative Law to be approved and implemented.
