Event Recap: Annual Angels Game

At the start of May, the Los Angeles, Long Beach, and Orange County chapters hosted a joint event at the Los Angeles Angels game! Over 35 professionals attended the game and watched the Angels bring home a win!

Cal/OSHA Rulemaking Update: Fall Protection in Residential Construction

The Cal OSHA Standards board has approved updates to the fall protection standards to better protect residential construction workers. The updates are effective July 1st, 2025, and affect sections 1671.1, 1716.2, 1730, and 1731.

Notable changes to these sections include:

- The trigger height for fall protection when working on top plates, joists, and roof structure framing has been lowered from 15 feet to 6 feet above the level below.
- Specific fall protection requirements were established for working on interior framing activities between 6 feet and 15 feet above the floor level below.
- Expanded fall protection options for work on floors, starter board, roof sheathing, fascia board, and work performed outside the gable end truss or rafter.
- Fall protection is required for work on roofs with a slope of 0:12 7:12 when work is 6 feet or more above the level below and when the slope is greater than 7:12, regardless of height.
