Event Recap: ASSP Safety 2025

CalOSHA Updates: 8 CCR 1514 – Personal Protective Devices

The California Occupational Safety and Health standards board approved the adoption of the updated language in 29 Code of Federal Regulations (CFR) 1926.95 regarding Personal Protective Equipment (PPE). This updated language states that PPE must properly fit each affected employee.

While this is a small update to the section, it is an important reminder that in order for PPE to properly protect employees, it must be well maintained and used correctly. Improper fitting of PPE can greatly inhibit its effectiveness. Employees should be trained in the proper use of PPE and how to adjust the PPE (if applicable). When selecting PPE, keep in mind the employee population and the unique needs of the employees who will be using the PPE. If you notice that employees are not wearing their PPE, ask for feedback, the PPE may be uncomfortable, ill fitting, or not suited for the task they are used for.
